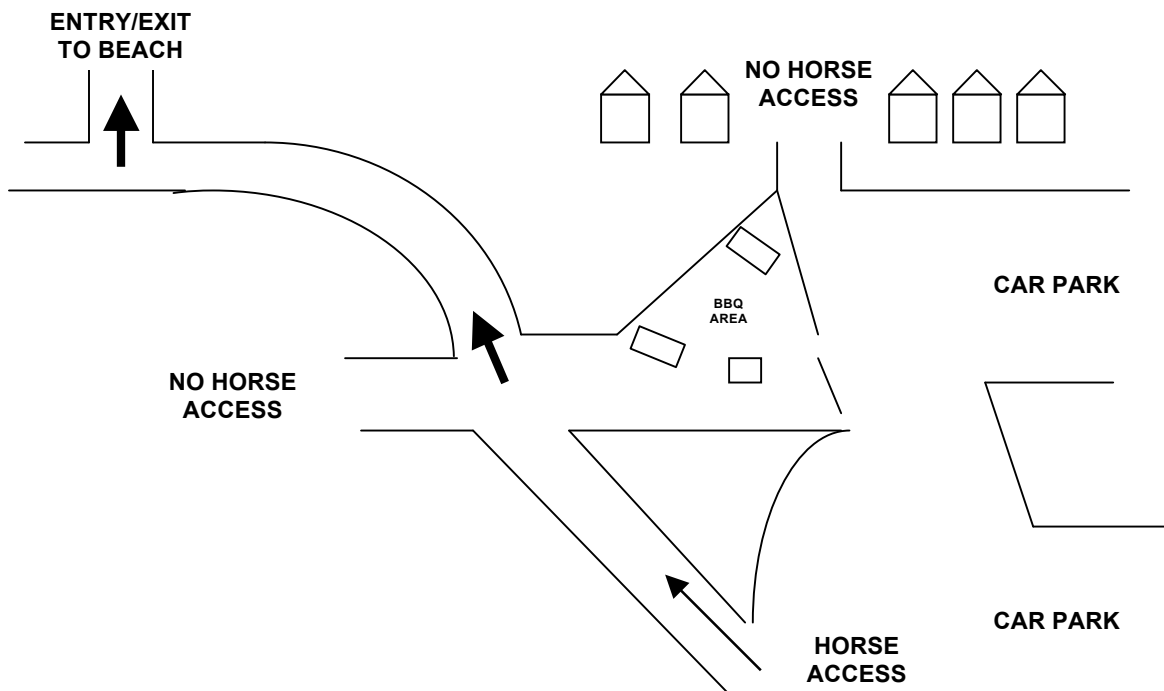

BEACH ACCESS

At Knoll Beach please enter/exit the beach by the route shown below:



CODE OF CONDUCT

- 1) It is the responsibility of the horse owner to ensure that each horse owned is covered by Public Liability Insurance for a minimum of £2,000,000 and that signing the Horse Riding Application Form confirms that the horse owner holds a valid certificate of insurance.
- 2) Horses must only be ridden along the tide line and **NOT** in the dunes.
- 3) Horses may **ONLY** enter the beach at the designated path which is approx 100 metres north of the Knoll Beach Centre or through the access point at Shell Bay. **Riding is not permitted south of the entry/exit path at Knoll beach or along the boardwalk over the reed bed at Shell Bay.**
- 4) Riding is permitted in either direction on the beach and a permissive bridleway along Ferry Road links to other existing bridleways.
- 5) Studland Beach is visited each year by approximately one million visitors. Please pay due care and attention at all times to other beach users.
- 6) **NO GALLOPING** is permitted on the beach and due care and attention must be given to other beach users.
- 7) Ensure that all straw and manure is removed before leaving the site.
- 8) Horse boxes/trailers must be parked with consideration to other car park users in the left hand car park below the Discovery Centre. **Please pay at the PAY & DISPLAY machines** (some machines accept credit/debit cards). **Parking is free to National Trust members** (please scan your card and display your valid ticket on your vehicle). For more information on membership please enquire at Knoll Beach Office.
- 9) All persons are subject to the National Trust Byelaws.
- 10) This permit is not transferable.
- 11) The permit holder must indemnify the Trust against all liabilities arising in connection with the exercise of this permit.
- 12) Annual permit holders; permits must be displayed visibly at all times when riding.
Daily permit holders; please carry your signed paperwork with you and produce it upon request.
